Workers may be in residential facilities and or in community agencies and day centres, completing specialised tasks and functions in relation to leisure and health. While workers are responsible for their own outputs, work is carried out under direct or indirect supervision within defined organisation guidelines. In order to undertake your practical placement and secure employment in the future students are required to obtain a current clear Victorian Police Check and Working with Children Check card.
